6. Financial Statements

The audited financial statements are contained in the Annual Report.

Des Button asked what the board was going to do to reverse the trend or rectify the bleeding of member's funds, with a loss of over the past 2 years of \$342,000.

Tim Dodds, Chair, acknowledged the questions outlined the increase of expenses across the board. Grants and Sponsorship have dried up. However, CEO, with the support of the board, will work to rectify this.

Louise McDermott, CEO, spoke of the impact Sponsorship and Grant funding have had on the Bottomline and the strong focus that will be put on Sponsorship moving forward, as well as the Night Owls/social participation, getting the data on the BowlsLink database, to assist with grants and sponsorship opportunities.

Robert Crabbie asked if there is a budget for this year and is it a surplus budget.

Louise McDermott, CEO, responded, there is a budget it is a deficit one, I have been tasked by the board to review the budget and reduce the deficit.

David Lamand asked about the High Performance \$88,000, Marketing up \$28,000 for expenses, and tournament income up 66% in the past two years. Country members can't keep paying for the high performance.

Tim Dodds, Chair, thank you, David; Marketing and other areas where postable will be brought back in-house. CEO can speak to the High-Performance expense.

Louise McDermot, CEO, thank you, David. High-performance expense is high, and Nationals hasn't been able to run for two years due to COVID, the timing of the event, school holidays, flights, and catering increase. The inclusion of the Para and Over 60's sides, no longer subsidising their own expenses, has led to enormous expense. Bowls Australia, as well as all other states, are reviewing this program for the future.

Karen Gatto, Bowls SA Board member and a High Performance athlete, I would like to just add that this year, all athletes are subsidising all of their own meals and daily allowance.

Affiliation discussion was had on how to increase participation and get the participants onto the database.
